# Weaving Digital Threads into India's Green Gold

India's jute industry accounts for over 60% of global jute output and supports more than 4 million farmers across West Bengal, Odisha, Bihar, and Assam. Yet for decades, this ₹13,700 crore sector operated through fragmented, paper-heavy processes — with stakeholders working in silos and policymakers governing on stale data. CSM Technologies stepped in to change that, delivering a Unified Stakeholder Portal that is redefining how an entire industry operates, communicates, and grows.

## The Gaps That Demanded Change

India's apex jute authority independently administers 15+ schemes, spanning cultivation support, market promotion, diversification subsidies, and scholarships, each managed in complete isolation. There was no central beneficiary registry, no standard approval workflow, and no real-time visibility into scheme performance. Applications moved physically between offices. Beneficiaries had no way to track their status. And without integration with national systems like Aadhaar, Public Financial Management System (PFMS), and Bharat Maps, verification gaps and payment delays were unavoidable.

The sector didn't need incremental fixes. It needed a complete digital backbone, built from scratch, designed for scale.

## The Digital Turning Point

CSM Technologies designed and deployed a Unified Stakeholder Portal, a single web and mobile platform integrating every scheme, every user group, and every workflow across the jute value chain. Built on a shared data backbone, the portal connects farmers, mills, traders, exporters, and regulators under one roof, with Aadhaar-linked beneficiary registration, OTP-based authentication, and configurable multi-level maker-checker approval flows.

Disbursements flow directly through the Public Financial Management System (PFMS) and Integrated Financial Management System (IFMS) via Direct Benefit Transfer, with SMS and email alerts confirming every transaction in real time.

- **National Systems Integration:** Connected with UIDAI, PFMS/IFMS, Prayas Portal, and Bharat Maps for seamless verification and compliance.
- **Security & Compliance First:** HTTPS/SSL, CERT-IN audited, GIGW-compliant, with role-based access control and a full disbursement audit trail.
